KILLING I-960 (THE TAXPAYERS' PROTECTION ACT)

Earlier in the session, the majority party voted to eliminate Initiative 960, known as the Taxpayers' Protection Act, which requires a two-thirds vote of the Legislature to raise taxes. The voters of this state have made it clear time and time again that raising taxes should be difficult and used only as a last resort.

BUDGET, TAXES, AND A SPECIAL SESSION

Despite all the rhetoric, platitudes and promises, at the end of the day, **state spending has decreased by only 0.8 percent from last year's budget.** When compared to the private sector, where more than 189,000 jobs have been lost since the beginning of the recession in February of 2008, this small cut in state spending represents a serious disconnect from reality.

We offered the majority party more than \$750 million in government reforms and efficiencies, but were ignored. And, because their budget solution to our state's \$2.8 billion shortfall relies so much on one-time money, the practice of adopting unsustainable and unrealistic budgets continues. As a result, **we will most likely see another multi-billion dollar shortfall next session.** This is not responsible governing; this is not accountable leadership.

Families and employers were hit especially hard as the Democrat majority passed new and increased taxes amounting to nearly *\$1.7 billion for the 2011-13 budget cycle (\$794 million in just the first year alone)*. This is **the**

largest tax increase in state history. Following is a small sampling of these new and increased taxes which will further hamper our state's economic recovery and lead to more job losses (dollars are in millions):

TAX PLAN	Next Year	2011-2013
A 0.30% increase in the B&O tax on all services except hospitals and scientific R&D =	\$242	\$483
Cigarette(\$1 per pack) and other tobacco products =	\$101	\$198
50-cent per gallon (28-cents per six pack) beer tax =	\$59	\$118
Sales tax on bottled water =	\$32.6	\$69
Sales tax on candy/gum =	\$30.5	\$62.4
2-cent per 12-ounce soda tax =	\$33.5	\$72.4
B&O increase on certain canned meat (SPAM) products =	\$4.1	\$8.8
B&O tax increase on mortgages =	\$3.6	\$7.9
B&O tax increase on corporate officer salaries =	\$2.1	\$4.6
Tax increase on livestock nutrient management (manure) =	\$1.3	\$2.8
Tax increase on PUD electric bills =	\$1.2	\$2.2
Personal liability for tax debts =	\$1	\$2

We continue to believe that tax increases are not the answer to our state's budget problems. State government has grown too big, too fast and state spending must come back into alignment with state revenues.

Remember, just a few years ago, our state had a budget surplus of around \$2 billion! But overzealous legislators increased spending by over 33 percent (nearly \$9 billion!) in just four years.

We need to get back to the proven success of the Priorities of Government process. We need to define and establish our state's core functions – and then fund those first. The era of a bloated, top-heavy state government must come to an end. And, just like families and employers across the state, we need to look for new efficient ways of getting things done.

PUT THE FEDERAL GOVERNMENT BACK INTO ITS CONSTITUTIONALLY-DESIGNED BOX

We're very concerned about the federal government overstepping its constitutional bounds in meddling with matters reserved to the states. The clearest example is the newly-adopted federal health care reform legislation. The 10th Amendment to the U.S. Constitution declares: "The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people." We will continue to defend our state's constitutional rights, including fighting the federal takeover of health care.
